PRE-BID MEETING- SGO OFFICE RENOVATIONS SCOPE OF WORK

Scope of Work

- 9400 SF of space in the Popp Martin Student Union Building.
- Work includes demolition, new ceilings, flooring, light fixtures, partitions, and MEP.

Construction Schedule

- Start Date: December 20.
- Construction Completion:
 154 consecutive calendar days from NTP.
- Liquidated Damages for late completion are \$100/day.

- Licensed General Contractors may obtain documents upon deposit of \$100.00 in cash or certified check (to Little), mailed to Sharpe Images.
- Plans will be sent via Fed-Ex 2-day.
- The full plan deposit will be returned to those bidders provided all documents are returned in good, usable condition within ten (10) days after the bid date.

BID FORMS

Included Forms

- Bid Proposal
- Identification of Minority Business Participation Form, with Affidavit A or Affidavit B as applicable.
- Forms and Instructions ae included within the proposal Form in the Bid documents.
- Failure to complete these forms is rounds for rejection of the bid (GS143-128.2c, Effective 1/1/2002).

Licensing Requirements

- All contractors are hereby notified that they must have proper license as required under the state laws governing their respective trades.
- Chapter 87, Article 1 will be observed in receiving and awarding general contracts.
- Unlimited General Contractor license classification is required under G.S.87.1.

Licensing (cont.)

- A single-prime project that involves other trades requires the single prime contractor to hold a proper GC license.
- EXCEPTION: On public buildings (single-prime bid) where the total value of the general construction does not exceed 25% of the total construction value.
- Final Addendum will be issued by 5:00 pm **on November 19, 2021.**



BID FORMS

Bid Bonds

- Each proposal shall be accompanied by a cash deposit or FDIC certified check of an amount not less than 5% of the bid.
- Alternatively, a bidder may offer a bid bond of 5% of the bid executed by a surety company licensed under the laws of NC.

Performance and Payment Bonds

- Required for 100% of the contract price.
- Payment will be made based on 95% of monthly estimates, and final payment made upon completion and acceptance of work.
- No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of 60 days.

Liquidated Damages

- GC Cash Deposit shall be retained by the owner as liquidated damages in event of failure to execute the contract within ten days after the award.
- During construction, Liquidated Damages are \$100/day for late completion.



Minority Business Participation

Bidder shall include the form **Identification of Minority** Business Participation and shall include either Affidavit A (Listing of Good Faith Efforts) or Affidavit B (Intent to Perform Contract with Own Workforce) as applicable. Forms and instructions are included within the Proposal Form in the bid documents. Failure to complete these forms is grounds for rejection of the bid.

"Good Faith Effort" Requirements

Bidders should be familiar with the Guidelines for Recruitment & Selection of Minority Businesses for Participation in University of North Carolina Construction Contracts.

- The University has a goal of 10%
 MBE participation.
- Last day to notify potential MBE subcontractors is Friday, November 19, 2021.
- Last day for assistance from Charlotte HUB Coordinator is COB Tuesday, November 16, 2021.

BID FORMS

"Good Faith Effort" Requirements

- Contacting minority businesses that reasonably could have been expected to submit a quote at least ten days before the bid date.
- Making the Construction
 Documents available for review
 by prospective minority
 businesses at least 10 days
 before the bid date.
- Breaking down or combining elements of work into economically feasible units to facilitate minority participation.

GFE Requirements, cont.

- Working with minority trade, community or contractor organizations identified by the HUB office.
- 5. Attending any pre-bid meetings scheduled by the public owner.
- Providing bonding/ insurance assistance of providing alternatives for subcontractors.
- Negotiating in good faith with interested minority businesses, and not rejecting them as unqualified without sound reasons based on their capabilities.

GFE Requirements, cont.

- Providing assistance to an otherwise qualified minority business in need of equipment, loan capital, lines of credit, or joint pay agreements to secure loans, supplies, or letters of credit.
- 9. Negotiating joint venture and partnership agreements with minority businesses.
- 10. Providing quick pay agreements and policies to enable minority contractors and suppliers to meet cash-flow demands.

Alternate #8


- Provide owner-preferred campus standard HVAC controls alternate as follows:
- HVAC Controls: Lon and bACnet.




